

FEES

For residing in the Halls of Residence at Gdańsk University of Technology in the academic year 2020/2021

1. We hereby establish the following rates for residing in the Halls of Residence at Gdańsk University of Technology

a) GUT students and Ph.D. students

b) Spouses and children of GUT students and Ph.D. students, when occupying a standard place – prices as for point 1.a) plus 100,00 PLN (per month).

c) Students of other universities and GUT graduates from 2020-2021 who have received permission from the Vice-Rector for Education to reside in the DS pay the fees as for point 1.a) plus 100,00 PLN (per month).

d) Other residents (GUT employees, other persons who are not students), who have received permission from the Vice-Rector for Education to reside in the DS pay the fees as for point 1.a) plus 300,00 PLN (per month).

e) Students' and Ph.D. students' children who do not occupy a standard place – free of charge.

f) Participants of exchange internship programs organised by other universities, candidates to study, participants of preparatory courses, workshops, and GUT part-time students (temporary rent) 30 PLN /night.

2. At the written request of a resident, and with the consent of the Head of the Student Residential Campus, an additional person can be quartered in a single room - fee for two people as for places in a double room. (In the case of Dorm 12 - fee for two people as for places in a single room).

3. The fee for an incomplete month is calculated by daily rate (price per month / number of days in a month).

4. The deadline for payment of fees:

a) GUT students and Ph.D. students - the 20th day of the month

b) other residents - the 10th day of the month.

5. Fees for missing and damaged equipment are determined by the Dorm Head according to average market prices. If the perpetrator is unknown, the fee for that month, for the residents of the segment / floor in which the event took place, is increased - the decision to impose additional charges is made by the Dorm Head in consultation with the Student Residents' Council.
6. Temporary rent of beds:
 - a) student's guest - a resident of another GUT Dorm – free of charge
 - b) other student's guests - 12 PLN /night
 - c) Dorm guest (if there are free rooms) 50 PLN /night / place
 - d) guest room (Dorm 4)
 - Stay till 7 nights 120 PLN /night / double room (an additional person – 30 PLN/night)
 - Stay over 7 nights 100 PLN /night / double room
 - full month 900 PLN / month / place
7. The fees quoted are gross.
8. Exemption from VAT is subject to accommodation provided to GUT students and Ph.D. students and students of foreign universities on the basis of agreements concluded with GUT.
9. The guarantee deposit in the amount of 300 PLN is introduced, which will secure the proper performance of obligations by the student / DS resident. The rules for the deposit guarantee payment for residence in the DS are defined in the Rules of GUT Student Halls of Residence
10. In matters not regulated by this Fees list the Vice-Rector for Student Affairs is the person responsible.
11. The decision to change the Fees shall be taken by the Vice-Rector for Student Affairs after obtaining the opinion of SSPG (Student Government at GUT) and SDPG (Doctoral Student Government at GUT).

The Fees list, together with the above regulations is in force since 1 October 2020.
