Chairman (Maciej Jasiński) opened the session.

Nobody raised objections to the proposed agenda.

Point 1.

Maciej Jasiński sent a link to the report from the previous meeting. Nobody raised any objections to the report.

A vote on the adopting the report was held.

The report was adopted.

Point 2.

Maciej Jasiński discussed the actual doctoral self-government structure in GUT and compared it to doctoral governments from other universities. The concept of introducing a secretary, treasurer, sport and culture commission and media and promotion commission was presented.

Adam Olszewski volunteered to be the treasurer.

Małgorzata Rudnicka volunteered to be a member of sport and culture commission.

Jan Alfuth volunteered to be a member of media and promotion culture, responsible for government website.

Maciej Jasiński informed that detailed responsibilities for each auxiliary entity will be discussed with volunteers after meeting.

Point 3.

Maciej Jasiński informed about plans of the doctoral school council of introducing an ombudsman for doctoral students in the school regulations. Chairman discussed regulations about ombudsman institution in other universities and told about requirement of the potential candidates. During the discussion it was suggested, that there is no need of introducing separate ombudsman for doctoral students.

Point 4.

Maciej Jasiński asked about suggestion for changes in the doctoral school regulations.

Bartosz Trawiński said, that he sent a proposition for changes to the doctoral school council in November and asked to remind doctoral school council about it.

Point 5.

Maciej Jasiński presented a summary of the budget for previous year and informed that budget for 2021 will be similar and will be presented in March. Chairman asked if anyone has proposition for spending the budget.

Marcin Wekwejt proposed buying a license for doctoral students for writeful software.

Maciej Jasiński proposed, that before spending government budget on it, it is better to ask a library if they can buy it.

Joanna Niesiobędzka said, that she will aks in the library about writeful software.

Point 6.

Filip Kaźmierczak presented his idea about spending budget on buying materials and tools for building devices for plants cultivation. The proposition did not found an approval in the council.
